

### Saskatchewan Railway Profile

- Railways in Saskatchewan:
  - 3580 km of CN & CP Mainline
  - 2760 km of CN & CP Branchlines & Spurs
  - 2005 km of Common Carrier Shortline Railways
- Total Saskatchewan Railway network of 8345 km
- Currently 13 short lines in Saskatchewan (soon to be 14)
- Approximately 50 industrial railway shippers under provincial jurisdiction

### **Rail Services**

#### Mandate:

- Administer The Railway Act
  - Provide advice on the application of the Act;
  - Ensure compliance with Authorization and Approval Processes;
  - Advise Highway Traffic Board on issuance of Operating Authority Certificates, cost apportionment disputes and level of services issues.
- Safety
  - Carry out responsibilities and duties of Provincial Railway Inspector;
  - Establish rail safety policy for the ministry;
  - Evaluate and audit railway operations and safety plans;
  - Collect and evaluate railway accident/incident reports.
- Shortline Development
  - Provide advisory services to stakeholders considering shortline creation
  - Manage financial assistance programs offered by the Ministry

### **Rail Services**

#### Railway Operations under Provincial Jurisdiction:

- Common Carrier (shortline railways)
  - Operated for the purpose of transporting goods, and/or commodities for a toll or fee;
  - Subject to common carrier obligations under *The Railway Act*.
- Industrial
  - Owned and operated for primarily private use to load railcars with goods or commodities manufactured, processed, or handled by the industry.
  - Located within the confines of an industrial site.
- Amusement/Heritage/Passenger
  - Owned and operated by an amusement, museum, or heritage park for the sole purpose of providing train rides for the public;
  - Passenger rail is an operation for the sole purpose of carrying passengers either on common carrier track or on railway solely intended for passenger service.



### **Provincial Guidelines and Standards**

Why does Saskatchewan only have guidelines and no regulations?

- Regulations are cumbersome and difficult to create and change
- Regulations must be strictly enforced and don't leave much room for flexibility
- Transport Canada and federal railway industry has developed comprehensive set of railway standards, rules and regulations.
- We believe we already have sufficient authority and ability to enforce the applicable rules and standards without writing them into regulation.

#### **Railway construction or expansion requirements**

- All classes of railways must:
  - Obtain authorizations to construct and open new or altered railway track
  - Obtain authorizations to construct or alter crossings (road or utility)
- Railway is required to submit construction drawings stamped and certified by a professional engineer
- Any new or expanded railway infrastructure must be designed and constructed in accordance with applicable federal standards, AREMA standards, CSA standards etc.
- Industrial railways are required to submit an industrial railway registration form to provide a basic level of information about their rail related activities.

#### **Operating Authority Certificate**

- OACs are issued by the provincial Highway Traffic Board
- The Act allows the board to determine if a railway owner and/or operator have adequate insurance
- In the past, the HTB has not required industrial railways to obtain an OAC.
- New Requirement:
- As of January 1, 2016, all industrial railways will be required to apply for and obtain an OAC from the HTB.
- Industrial railways will be notified in writing of this change in the coming months.

#### **Safety Management Plans**

- The Act authorizes the Minister (or delegated authority) to order a railway to submit a Safety Management Plan
- Submission of a SMP is only mandatory if an order is issued to a railway.
- In the past, we have only asked new industrial railways to provide an SMP.
- Currently in the process of harmonizing our SMP guideline and required components with the new federal SMS regulations.
- New Requirement:
  - Will eventually require all industrial railways to submit an SMP.
  - No specific deadline for all railways to submit a new SMP.
  - Will phase in this requirement by issuing orders to submit new SMPs over the next year or two.

#### Further changes and updates

- Over the next few months, we will be updating our existing provincial railway standards and guidelines.
- Will also consider creating new guides specifically intended to address industrial railway operations.
- Intention is to provide additional information and clarity on provincial requirements and our expectations.
- Will use federal rules, regulations and standards along with AB and BC regulations and guides to improve our guidelines
